Enhancement of IWLP's efforts in AIS prevention and control is included in the cooperative agreement with the County. IWLP hired a coordinator for the Itasca County AIS Program. Educational efforts, hiring of level one inspectors and monitoring/inspection of watercraft at public water accesses in Itasca County were initiated.

4b (Code:) (Expenses \$ 5,633 including grants of \$) (Revenue \$) IWLP held a Youth Water Summit for 440 5th graders at the Itasca County Fairgrounds. 77 science presenters provided 44 presentations and there were 80+ adult volunteers.

4c (Code:) (Expenses \$ 7,489 including grants of \$) (Revenue \$ 7,989) IWLP organized a Healthy Watersheds Conference attended by nearly 100 adults, featuring 12 presenters and an afternoon World Cafe discussion of lessons learned those presentations.
