2021-11-01 Clean Water Initiative

Hello All,

I just wanted to give you a quick Clean Water Initiative update. Ed and I had a zoom meeting with Stephanie prior to the ICOLA October meeting. We talked with her about the initiative and the hope that Itasca Waters along with ICOLA and expertise from Soil and Water could work in collaboration to organize lake associations to strategically focus on the top three shoreland practices that make up the initiative. Stephanie is onboard with the idea and planned to talk with members about the initiative and also to let members know that Ed and I would be reaching out to association presidents in the coming months to learn from them.

Now that the October ICOLA meeting has happened, we will begin contacting 18 lake association presidents to achieve the following objectives: (a) To learn from them about what, if anything, their association is currently doing to address the three shoreland best practices. (b) To learn from them what barriers or obstacles they see in organizing their associations to focusing efforts on the Clean Water Initiative.

After we have a clear picture of who is doing what and what obstacles they foresee, we plan to have a handful of small gathers to dig deeper with lake associations around the initiative.

We will keep you updated as we move ahead with what we are learning. Please let us know if you have any questions or comments.

Report: 2021 Fishing Line Collected for Recycling By Shirley Loegering

We collected almost one pound of fishing line from the 13 collection sites at public fishing piers in the County. The collected line was mailed on November 1, 2021, to Berkley Recycling, 1900 18th St, Spirit Lake, IA 51360

All receptacles had been used, especially at Forest Lake and Crystal Lake. There was very little use at the container on the Mississippi River by the Library, and that was probably because the water level was so low all summer. There was a lot of garbage in all the containers (pop cans, plastic bags and packaging, candy wrappers, and cigarette butts). Scenic State Park found a dead Sunfish in one of their containers! I did retrieve a small amount of lead tackle for recycling.

Personnel at the Army Corps (3 sites) and Scenic State Park (2 sites) were pleased with the project, and they emptied the receptacles as agreed upon. None of the cities had their staff empty the containers as per our agreement. Perry and I checked the receptacles and cleaned them out about mid-October. Removing garbage out of the collected line was a rather nasty job. The photo below is of the total collected, after removing most of the debris.



Most of the covers to keep birds and garbage out will need to be replaced next spring.

I recommend we only do 12 sites next year by eliminating the one at Trout Lake in Coleraine. That site is rather remote, and it appears to be used more for parties than for fishing. After a second year, we can re-evaluate if we want to continue the project.

Recent Comments for Future of Itasca Waters Planning

Dave Lick:

- (1) With Paula leaving should we do away with the office? It seems a waste to continue to pay rent? Mary could be notified to get her kayak, the office furniture could be taken to Goodwill. The printer needs to go somewhere, the excess shoreland brochures can go to my old office. I have recently sold my share of the building. I met with Ed and Laura on Monday to begin planning for using the Bush money to engage ICOLA. You will need to let me know soon if you want that delayed. At this time I think it is worthwhile to engage the presidents of some of the associations to get ideas on what those presidents think IW and ICOLA should try to accomplish. Untapped and I did not think there was a large role for Paula but even still without a coordinator it could make more work that we can't facilitate. We need some dialog folks.
- (2) Past success of IW has been based on the activities of the working board. I would like to see 3 new board members added. Talents could include clerical, finance, science, marketing, business owner. Names can be shared when and if the existing board agrees to add. We have been discussing the board members since Jan 2020. People who have answered surveys, people who are on our mailing list and the newspaper should be used to solicit the new board members. In addition each board member should provide a name and be willing to give people a call to ask them for their service.

Office discussion should revolve around if we can afford to have an office, and where the office belongings will go if the office is closed. As for a mailing address we in the past used my office and we should be able to come up with an address so that the non profit can continue. We should be able to find meeting space once and if we go back to meeting in person.

If the shoreland steward program is to continue someone will need to coordinate requests for visits. In addition communication needs to be had with the 20 some advisors on a timely basis. Coordinator help is also helpful to membership. Considering IWs track record with coordinators is there a way to share a position with another organization? I still ponder the county employee who applied twice. Maybe that person would take on shoreland and membership and IW could hire hourly for additional projects we try to make happen. If the YWS comes about Community Ed will request help from IW and I am not sure what that means at this time. I am willing to do most of what I have done but that depends on whether my committee is still willing to help out. Please keep in mind that the coordinator hire was one of the main focuses when we requested money from Blandin. There was push back from the IW board for the coordinator to be the "face of organization" but I strongly feel that the person must be the face to carry the organization forward should we decide to hire.

Committees have not achieved the desired outcome, I think the original idea was good but there are not enough people within the organization to accomplish the work of the committees. The committee issue is the same as developing a strategic plan, they are good ideas but follow through is the difficult part.

Currently Untapped is going to reach out to ICOLA and determine how better collaboration and partnering can take place. SWCD should also be included in that discussion. W/O a coordinator I can't see any issue with this dialog. Maybe someone else will see that a coordinator is highly important with this project. Historically ICOLA has been difficult to engage. SWCD has paid

attention to what we do but there has not been good enough communication. Somehow the 3 organizations need to combine energies.

I will be interested to read what others are concerned about and whether there are readily available solutions to what board members suggest.

Jan Best: Ideas....

- ..hire someone on an hourly basis, more like a secretary. Maybe a temp service could provide us with someone.
- ..hire another person or find a volunteer to do strictly bulletins, you tube, and social media.
- ...hire Laura Connolly full time. Go back to Blandin and ask for more grant money to cover her salary. Apparently, Sonya suggested to Jesse we might want to do this. Blandin has skin in this game and might want to help out. Laura is the kind of professional we need. Perhaps she would take it on for a few years. Probably no need for the office if Laura were to do this.
- ..have a monthly zoom meeting for our entire mailing list ...purpose of which would be to engage our membership, see what ideas they have AND have some of them volunteer to do specific things that come up in that zoom. Without volunteers, the board will have more difficulty trying to fulfill our needs and projects. Do we need more board members or do we need more people engaged?
- ..Covid has made it more difficult in maintaining our connections with each other at IW and to follow thru with our mission. The pause has allowed us to reflect on the use of our time and what is important to us. That evaluation includes time spent on IW as well as our own personal time. I sense some of us may be rethinking how we engage with IW.
- ..part of our being out of tune, may be because of our current format of having board meetings every two months. At one point we were having executive committee meetings on the off month, but all board members were invited. We also tried having a meeting (all board members invited) on the off month just to discuss projects, concerns. That kept us more engaged.
- ..we should advertise for board members and volunteers in local papers, to our email list, radio,etc
- ..one idea to search for new board members and volunteers is to contact lake associations and ICOLA...they may know of someone and might advertise in their newsletters and mailings.
- ..some non-profits try limiting the terms of board members which prevents burn out, brings new ideas into the organization, and involves more people from the community directly involved in the flow. I think Laura could help us with that.

Shirley Loegering

When, and if, we bring on new Board members, we need to have an orientation (via zoom or otherwise) when they meet the Board in a more or less social setting (not a structured Board meeting) and when we could share our mission, goals, reasons for serving on the board, etc. Ed and Laura have done an amazing job and I feel we have not carried that momentum forward to the greatest advantage. Have we lost our focus?

Revisit the strategic plan and see where/why we failed.

We need active Board members with an interest and /or experience and knowledge in a lot of different fields, but for my part, I would like to see someone come on the board that would be

comfortable taking over the DonorSnap membership software. I was hoping that would be Paula as she jumped right in to take a lot of the training webinars, but . . .

Brian Whittemore

Itasca Waters is at a critical juncture, and I believe we have two choices.

- 1. It can grow into the organization it needs to be to make a larger positive impact on Itasca County's water and economy, or
- 2. We decide that we've gone as far as we can go given our current dwindling grant, staff, and volunteer resources.

The passion for clean water continues to be deep for board individuals and IW as an organization, but I think the passion for the work as an organization has dwindled among those who have done the work. That is very understandable given several factors.

I also don't sense much interest these days from board members who are not as active. There may be legitimate reasons why interest has faded among this group, but the signs of their apparent disinterest are obvious.

In short, I believe the Itasca Waters board is experiencing fatigue.

There has been discussion recently about Itasca Waters current role as a working board, rather than as a governing board, and I believe this is the key reason for our board fatigue. I feel that if we continue as a working board we are doomed as an organization. Even if the board increases in size, it is not likely that we will find enough people willing to do the necessary labor for free, given how busy folks are these days. If we decide to convert to a governing board and succeed at that in the near future (i.e., in 2022), I think we would have a good chance of rebuilding Itasca Waters and its ability to fight in a good way for clean water.

It will be difficult and complicated to rebuild as a true governing board, but not impossible. I recommend that is the direction IW should go. If, by the end of 2022, it has not worked out, it should not be for the lack of trying.

So, I recommend:

- 1. We concentrate fully in 2022 on conversion to a governing board and put on hold any projects not related to this effort.
- 2. We form a special Grants Committee, possibly including non-board members. This committee should focus solely on researching and obtaining grants allowing us to hire staff including an Executive Director, in addition to paying for any ongoing or new programs.
- We continue the work of the Membership Committee, but grow the number of people working actively with Shirley, possibly including non-board members. This committee should, in addition to continuing current efforts, explore methods of increasing donation sources from outside our membership.
- 4. We form a special Board Recruitment Committee, possibly including non-board members, to focus on enterprising methods to recruit additional board members. We need to be very creative about this, identifying and using tools to reach target audiences of all ages and walks of life. I also feel, as do others, that we should identify areas of expertise which would be useful to IW going forward and develop methods of finding and attracting board members who have those talents.
- 5. We consider using the money assigned to the Coordinator position to hire short-term assistants for each of the above committees. The assistants would be especially valuable for doing research.
- 6. It is essential that we hire a fulltime Executive Director. I do not believe that the working board concept can be sustained.
- 7. If we do not hire an Executive Director, we do not need an office. If we do hire an Executive Director, we do need an office.

Re: The Future of Itasca Waters, the Organization

I have been an active participant in Itasca Waters for nearly four years. During this time I've observed and contemplated our organization. At this point in time I have some thoughts about Itasca Waters that I need to share. My intention is to first share my thoughts with the IW officers, and after a little due diligence, with the full board.

1. Coordinator Position and Job Description:

- A. I believe it is time to restructure this position to clarify what she/he actually does for us.
- B. A part-time, relatively short term employee should not be "the face" of Itasca Waters.
- C. The position should be aimed at serving the committees in the background with detail work the committees require.
- D. The position should perform general ongoing IW clerical-type work delegated by the officers.
- E. IW may not need to maintain a physical office as it seems to be used as a part-time work space by the Coordinator and not for meetings with the public.
- F. Requests for the Coordinator's time should always go through the officers (Executive Committee), and the Coordinator and the board members need to be clear on this. Exceptions could be made if authorized by the officers in advance.
- G. One of the IW officers should be in touch with the Coordinator at the beginning and end of each week, and be available for questions during the week. As long as officers are in agreement about priorities and communicate adequately, the officer on deck each week could rotate.

2. Shoreland and Youth Water Summit

- A. These two major projects occupy an extraordinary amount of the Coordinator's time, often conflict with other work, and the conflicts have caused problems. When a new Coordinator comes on board the same things will occur and the problems will continue. So, changes need to be made.
- B. I suggest that we look at carving some money out of the Blandin grant to hire a per diem worker or workers to assist Dave as needed in setting up the YWS and managing Shoreland Advisors. Dave should hire and manage this person. IW would put a cap on this spending item, \$10k for instance, and Dave would manage hours and work.

C. When IW designated Shoreland as our new major initiative, we did not decide that the Advisors program be the sole part of the initiative. That idea came later. At this time we should consider adding new ideas to complement the Advisors program. I've got a few new ideas, Jan B. has some thoughts, and we should encourage other committee and board members to chip in.

3. The new IW Committee structure

- A. This is a tough one, but here goes. I do not think our new structure is very effective. It may be in large part caused by Covid, it may be that we are missing Dave as a strong-armed leader, it may be that only a small number of the board is active, and probably it is a combination of all these things.
- B. For the most part committees are not meeting or doing work. There are exceptions, but primarily on the part of individuals doing the work rather than committees.
- C. We spend too much time creating rules and charters, which effectively describe our organization and its parts but do not contribute to progress. I realize this process is necessary I would just like to see more emphasis on getting our message of good water stewardship out to the community and less on rules.
- D. We need new board members, but not just bodies. We should identify what needs our organization has, what weaknesses exist, where we need strengths, and then try to find people who might fill those needs and who would be committed.

If you agree that we have a problem, please do some thinking and let's kick it around together. If you disagree, don't sit and steam, let me and the recipients of this letter know what you think.

There are some people who have spent an extraordinary amount of time assisting IW in its mission and we need to firmly recognize that. Keep in mind that we could use some of the Bush money for assistance for board issues if someone comes up with a concise plan of what could be done. Please keep me in the loop and let me know what you decide to do. Thank you. Dave

IW FUTURE: Jan Best

Perhaps IW does not need to hire one part time 20 hour per week person as a coordinator. There may be an alternative that will meet our needs.

IW, as one of our priorities, is to act as an educational disseminator. This past year, while working with Zack, I came to the conclusion that we have underestimated social media, website, and our You tube channel in being a conduit for sharing important information. By incorporating short videos into our newsletters, and on all our platforms, we were able to expand our reach. However, to be effective, all of these ways of sharing information needs to be done frequently with someone who is versatile in these platforms.

My idea is to hire a person by the hour to work just on these platforms, kind of a media consultant. This person would be responsible for arranging videos with community members, producing them, and putting them on our platforms. We would be the ones to come up with the ideas, the people to be videoed...basically, the content. We would write and edit the IW Bulletin segments, they would put it together in an interesting format with photos and videos, and would email it out. Over the past year we have increased the number of people we email our newsletter to which then makes our name more visible in the community and helps in our fundraising drive.

This person would maintain the website, adding content we send them....especially expanding our news blog. Again, we need to provide the content. They provide the expertise. Perhaps one board member per month could be responsible for coming up with content for that month to be placed in the news blog.

I am in agreement with Brian that Dave should hire and manage a person, per diem, to work on the YWS and Shoreland Advisors. The YWS could be budgeted thru Blandin, and Shoreland Advisors thru Bush. Ultimately, it would be nice to have a fundraising drive for the YWS and/or have the school district and county provide more monetary support for this worthwhile event.

The above plan gets away from using these hires as the face of IW (we should be the face) and removes them from doing clerical committee work. However, both of these per diem people could add completed documents we send them to Google Drive.

In regards to the new committee structure, my main concern is I would like to know more about what each committee is doing. We talked about having each committee submit a short bullet point report about what they are doing, prior to our board meetings. That way, rather than using our time listening to committee reports at our board meetings , we can focus on discussing and adding helpful input to each committee's bullet point report.

I would like to see the full board meet more frequently in the early part of the year, perhaps monthly from January to April when we're planning and coordinating our more active time of the year.

Board recruitment to meet our needs is a great idea!

This has been an unusual year. It has made it more difficult to expand our committees or create new ones. Certainly Zoom has helped keep us afloat and has opened up the possibilities for how we use it in our committee structure in the future. Personally, because we live an hour away, I have found the meetings have saved tremendously on my personal time. Since Zack is no longer setting up our Zoom meetings on our IW account (which allows for more than 40 minutes), we may want to consider how we will handle them in the future in case we need more than 40 minutes. Can we have more than one person set up a Zoom meeting?

For some reason, I find my head spinning from all the requirements in the committee charters. Are we making it too structured to the point we're negating creative opportunity and ideas?

We need to take care the Executive Committee does not become what it used to be...doing all the work and leaving other board members out of discussions and decisions. Opening up all Executive Committee

meetings to everyone on the board would alleviate this. We just started inviting all board members so that's a good step.

I think one lesson learned from Zack's employment is he had more work assigned to him than he could accomplish in a 20 hour week. We do need a system, whether it's a liaison or the executive committee, to manage work loads. And we need to scale back. It's also important to continue with our putting together an employee handbook that outlines grievance procedures, and a grievance procedure for board members regarding an employee.

(Jan's Comments are in Bold)

I have been an active participant in Itasca Waters for nearly four years. During this time I've observed and contemplated our organization. At this point in time I have some thoughts about Itasca Waters that I need to share. My intention is to first share my thoughts with the IW officers, and after a little due diligence, with the full board.

I suggest that the officers, Shirley and Lynn have a Zoom meeting to discuss this. I added Shirley because she is getting a broad view of office operation and assets. Lynn has considerable experience working with IW hiring.

1. Coordinator Position and Job Description:

A. I believe it is time to restructure this position to clarify what she/he actually does for us. Great idea. We likely need to briefly survey a few folks and ask for a list of Zack's work over the past year. I know that my work with him on Google Drive may not have been in the original job description.

B. A part-time, relatively short term employee should not be "the face" of Itasca Waters.

I agree. Perhaps part of the problem is that many would love to have an executive director but circumstances just don't allow that.

C. The position should be aimed at serving the committees in the background with detail work the committees require.

I agree that the position should focus on well-defined, regular, ongoing work which will likely mostly be clerical. An exception might be the video work.

D. The position should perform general ongoing IW clerical-type work delegated by the officers.

I am OK with the clerical work idea but strongly feel that there must be one point of contact between the coordinator and the Board to avoid the multiple boss problem. An exception would be regular, ongoing tasks (to be defined).

E. IW may not need to maintain a physical office as it seems to be used as a part-time work space by the Coordinator and not for meetings with the public.

Before we get rid of the office, we need to figure out storage for equipment (which has to be accessible) and documents. There is a box there now of what looks like financial materials that Pat may want to review. At the risk of pushback, we should have a document retention policy that identifies what we need to save and converting all paper into digital files.

As I recall, the thinking was that the office could provide a committee meeting space and post-Covid, perhaps this will happen.

F. Requests for the Coordinator's time should always go through the officers (Executive Committee), and the Coordinator and the board members need to be clear on this. Exceptions could be made if authorized by the officers in advance.

As stated above, I think there needs to be one point of contact. However, the officers should prepare guidelines which might offer pre-approval for some tasks.

G. One of the IW officers should be in touch with the Coordinator at the beginning and end of each week, and be available for questions during the week. As long as officers are in agreement about priorities and communicate adequately, the officer on deck each week could rotate.

I am not sure about the rotating idea. It might work if there is a very limited, simple task list. Frankly, I think it would be stressful for the coordinator.

- · The spread of aquatic invasive species, AIS is accelerating.

Minnesotans love our lakes and we love our boats, but with this increased use has come the need for more training in boating safety, etiquette, AIS protocols and best practices to avoid negative impacts to lake ecology, water quality and fisheries.

Dear Commissioner Strommen,

We are writing to encourage the MN DNR to include the creation of a mandatory watercraft operator's safety certificate in the 2022 Agency language to be considered by the MN Legislature during the 2022 Legislative Session.

Boating in Minnesota is changing in dynamic ways. The size, power and number of boats in Minnesota is going up with a 36% increase in the last twenty years. The number of boats between 16ft and 26ft has increased 118% while the number of boats less than 16ft declined 27%. From 1987 to 2001, average horsepower went from 46.1 hp to 74.5 hp. Following a contraction during the 2008 recession, the trend towards larger and more powerful boats has accelerated. The COVID-19 pandemic has driven a boom in boat sales for the last two years.

Minnesotans love boats and own more than any state except Florida. For a state that benefits so much from outdoor recreation these increases are exciting. But some problems are starting to emerge that would be best addressed with the increased education and focus on personal responsibility a boat operator's permit program would provide:

- MN DNR reports that this was the deadliest summer on MN's waterways since 2005,
- There are some early indications that boating violation rates, as well as conflicts due to poor boating etiquette and lack of knowledge about "rules of the road," are increasing. This is particularly concerning since the US Coast Guard estimates that "81% of (boating) deaths occurred on boats where the operator did not receive boating safety instruction. Only 14% percent of deaths occurred on vessels where the operator had received a nationally-approved boating safety education certificate.
- The threat of aquatic invasive species puts additional responsibility on boaters to prevent the spread. Education is the first line of defense in AIS prevention suggesting the need for increased training, particularly for more complex watercraft.
- Enhanced wake watercraft, EWW are a rapidly growing and exciting new sector of the boating industry, but EWW can, if used improperly, cause more shoreline erosion,

- destruction of aquatic plants, and the disturbance of lake bottoms than traditional watercraft. EWW are also at very high risk of transporting AIS due to the ballast tanks they carry according to research by MAISRC.
- The increased speed and power of watercraft today require a greater degree of skill and knowledge to operate safely.
- With more boats on our waters and a wider diversity of recreational boating activities, conflicts among users are becoming more common.

Using the educational platform a boat operator's permit would provide, we can build a productive lake ethic based on a good understanding of lake and river ecology, the rights and enjoyment of all users, reduce conflict and increase enjoyment of our lakes and rivers. The promotion of hunting ethics through gun safety training has been a resounding success and the same model can be used in boating.

Secchi Disk Readings

This morning I have to say: "Thank you Mother Nature for the recent rain." We have been spanked and sent to bed all summer with little water for our lake. "OOF-da, that hurts."



I was asked to summarize the secchi disc measurements for Shallow Lake. A secchi disc is an 8" white disc with a small diameter rope tied to the top. The white rope is marked at 6" and 1 foot intervals. When dropped into the water, you count the number of feet and inches from where you lose sight of the disc to the lake surface.

These readings have been taken for years.

Water samples are also sent every month in the summer to a laboratory for chemical analysis.

The data is studied by the PCA to determine the health of the lake. Since 2019 the secchi disc readings that I've taken have shown a maximum depth clarity of 18.5 feet in June and a minimum reading of 13'9" in May. These clarity readings depend on precipitation, tree pollen, and human caused pollution.

All in all, Shallow Lake is doing well with no decline in clarity.

We should all do all we can to maintain it.

ICE FISHING ETIQUETTE



As we are saying goodbye to fall, we are saying hello to snow, and cold temps. Cold temps mean the lake will be freezing over. Ice fishing has become a Minnesota stable for those loving the outdoors. Everybody can appreciate the great outdoors, being in nature and disconnecting from the world, and of course, the allure of pulling in that monster catch. Here are some points to "ice fishing etiquette".

Be Mindful of Other Drilled Holes

Make sure you look out for other angler's drilled holes when looking for a spot to fish on the ice.

If you venture near to another ice fisherman, then make sure you are not encroaching on their immediate area and drilling too close to their holes. People will often drill several holes around themselves and plan to hole hop between them. If you are on a busy lake and come across somebody fishing in multiple spots, then show common courtesy and ask them before drilling a new hole or even using one of their drilled holes. The main problems encountered on the ice are usually down to people being lazy and not wanting to drill their own holes. They will see an ice fishing shelter and move towards it and take one of the nearby holes, so they don't have to drill their own. Unless of course it is an old hole unoccupied on the ice, then, go for it!

Keep Your Distance

This is super important for several reasons. First things first, safety. We all know that ice fishing has its danger element, especially during the early and late season. People are often a bit too keen to head out onto the ice and end up getting out there way too early when the ice isn't thick enough. It is also important to consider the distance out of courtesy. People don't enjoy being cramped up, especially when they are trying to fish in peace. As a rule of thumb, if there is plenty of room, then use it. There is no need to get cozy on the ice, even if it is cold!

Keep Quiet

There is often debate over whether fish are spooked by the sounds we make above water (ice).

Regardless of whether the fish can hear the noises we make above the ice, it is important to keep quiet for the sake of courtesy. Fishing is meant to be for spending time outdoors, being in nature. Don't come to the lake with big speakers and ruin the atmosphere for everybody else. Of course, augers can cause a lot of noise, but there is no way around this. Don't drill holes mindlessly just for the sake of it. (Continued on next page)

Have a License

Okay, so this one goes without saying. Have a license and fish legally. Not only does this keep your back covered from hefty fines, it also helps to keep the lake maintained, stocked and healthy so you can enjoy fishing there. Simply visit the state websites for more information.

Be Aware of State Laws

Make sure you have a quick brush up on the state laws if you are not a local or are new to ice fishing. There is usually a rod limit per person. States usually have a minimum distance requirement between each fisherman or between houses (shelters).

Even If You Live There, the Space Is Not Yours by Right

Don't make others feel unwelcome by informing them that they are in your spot. Whilst I do understand this, it is simply incorrect. These lakes are public lakes, which means that they can be fished by anyone, even if they are out of state. As always, communication is key here. If you are the local, then try not to make others uncomfortable for fishing on "your spot".

Pick up Your Trash - Leave No Trace

Okay, this is a **big one** for me personally. Nothing annoys me more than seeing people leaving their trash all around the area where they have been fishing. These magnificent lakes are stunning, and it's a shame to see them spoiled by people littering and leaving trash there. Do everyone else a favor and pick up after yourself and keep the area as you found it. Leave no trace on the ice so the next person can enjoy it too. Be mindful of other's space and above all communication is key. If somebody is getting too close, then let them know politely.

Water Withdrawal from MN Lakes

Questions have been raised about the construction trucks drawing water from Shallow Lake this summer and whether this may have contributed to the low lake level this summer. Greg Root, Region 2 Water Appropriations Hydrologist for the MN DNR, was kind enough to send information regarding this.

*What are the regulations that construction crews, pipeline or roads, need to follow in drawing water from lakes? Water appropriation is covered under MN State 103.G and the DNR requires a permit when someone is going to use 10,000 gallons /day and/or 1,000,000 gallons/year. A permit is only issued if it is determined that the water can be used safely and at both volumes and pumping rates sustainable for the source without causing negative impacts.

*Did the project for construction of Highway 2 have a permit? Yes, MN DOT had a permit to take up to 2 million gallons combined from three separate water sources, one of which was Shallow Lake. Water was used for dust control and for compaction. Getting good compaction of the road bed prevents excess settling in the future so the road will hold up longer before it begins to crack. The trucks

generally haul 3,000 to 5,000 gallons of water in a load.

*Could this have contributed to the lake level drop in Shallow Lake? I am confident in saying that the water use did not cause any noticeable drop in Shallow Lake. This year we have seen a drought like we haven't seen in decades and it was the drought that caused the low levels. Shallow Lake has an approximate surface area of 539 acres. MN DOT was allowed to take 2,000,000 gallons from 3 sources. I don't have an exact volume of how much they ended up taking from each source so we will calculate based on 1/3 (666,000 gal.) and all the water (2,000,000 gal.). You can google to find a conversion calculator to change gallons to acre-inches, then divide by 539. You would find that had they taken all their water at once, it would have equated to a drop in the lake of 0.045 inches for 1/3 of the water and 0.136 inches for the full 2,000,000 gallons. In a typical wet year no one would have noticed a drop in lake level of 1/10th of an inch but because the lake was already so low, naturally people would have begun to ask why. The water trucks were the only real visible thing happening.

*The MN DNR has strict rules for periods of drought. Once a watershed as a whole reaches a protected flow rate, we suspend all non-essential water uses. This happened and MN DOT's permit was suspended on July 27, meaning they had to stop using water from Shallow Lake even though that use was not causing the low level and it had a beneficial use.

As the seasons change, so do the lives of those who are residents of our lake. In recent months we have been made aware of the loss of several members of our lake family. They are:

Shallow & Sand Lake Association Annual Meeting

Latimer, local phenologist, spoke about the local flora and fauna and the changes
occurring. We are now on alert that there will be hungry bears this fall as there is
little to eat in the woods due to the drought, and that reproduction will likely be down also.



Following introductions, Faye Klande gave the treasurer's report (Checking account \$1382.53 and CD balance \$6517.27). Loon observations were discussed as was moving the loon next platforms to a better location on the lake. Dave Plude, board member, addressed the concerns of using lead tackle which has a negative effect on fish and fowl. He offered information about the Lead Free Program which offers an opportunity to exchange lead tackle for lead free nontoxic tackle (nontoxictacklegettheleadout.com).

The newsletter is our most reliable way to connect to residents and thanks was extended to Tanner Spawn who has done the printing of the newsletter for a discounted rate for many years. Because he has moved from the area, we will be looking for a new printing service.

Activities for the past year we reviewed including Second Friday meet-ups in the lake, the 4th of July Boat Parade and jet "fly-over" and the Ice Cream Social/Corn Hole Tournament, all of which were well attended and enjoyed.

INFORMATION REGARDING GARBAGE AND RECYCLING

Itasca County Waste Disposal

The nearest Transfer Site to the Shallow Lake and Warba area is located just west of the Swan River junction of MN 65 and 2. Watch for the sign and follow County Road 476 a short way to the site. While it is still listed as an Outlying Canister Site on the website, those of us who have used the site know that they are accepting more types of waste than previously. Recycling does not have to be sorted, other than to keep glass separate, and cans, paper, cardboard and plastic (though not plastic grocery bags) are accepted. Garbage can be dropped off for a minimal cost (75 cents for a kitchen bag; \$1.50 for a 20 gallon bag), using punch tickets which can be purchased at Lucky Seven gas station in Swan River.





When certain household chemicals are not used up, they can become household hazardous waste. Many household products contain the same chemicals as strictly regulated industrial waste and pose similar environmental and health problems. Although the qualities from one household can be small, with many household, it can

add up. If the container has words such as: caution, poison, acid, lye, corrosive, flammable, etc., do not dispose in the trash or pour them down the drain, as they may end up in the lake or ground waters. See the Itasca County website for information about disposal at the Cohasset facility at no charge.

Even if you have given your vote and proxy, you may still vote VIRTUALLY if you attend the Annual Meeting.

Each MLR voting member is entitled to one vote. Only persons who are voting members as of November 15, 2021 are entitled to vote at this Annual Meeting of Members to be held on Wednesday, December 1, 2021.

You may vote VIRTUALLY by attending the Annual Meeting or you may vote by ballot. If you vote by ballot, you must sign, date and return the enclosed ballot to:

A self-addressed envelope has been included for this purpose. If you sign and return the ballot on time, your ballot will be voted as you have directed. If you do not specify on your ballot how you want to vote, your ballot will automatically be voted as follows:

FOR Proposal No. 1 — Election of directors as described below.

The management of MLR does not know of any other business that may be presented for and require a vote at the Annual Meeting of Members. If, however, any other business should properly come before the meeting or any adjournment or postponement thereof that requires a vote of members, the directors named in the enclosed ballot and proxy will exercise their discretionary authority to vote your proxy in accordance with their best judgment. All ballots submitted by members entitled to vote will, unless otherwise revoked, be voted at the Annual Meeting and any adjournment(s) or postponement(s) thereof.

General Matters

Each director nominated to serve on the MLR Board will be elected if he or she receives a plurality of the votes cast at this Annual Meeting. Proposal No. 1 will be approved by the members if each proposal receives a majority of the votes cast at this Annual Meeting by members entitled to vote.

Revoking A Ballot and Proxy

If you mail in a ballot and later wish to revoke it or the proxy you have given before it is voted, you may do so by (1) sending a written notice to MLR at the address indicated in the Notice, (2) submitting a properly signed ballot with a later date, or (3) voting VIRTUALLY at the Meeting. If you do not follow any of these steps, your ballot will be voted as indicated and your proxy may be voted in the discretion of the board in accordance with their best judgment.

PROPOSAL NO. 1 Election of Directors
