Current balance: \$1,419

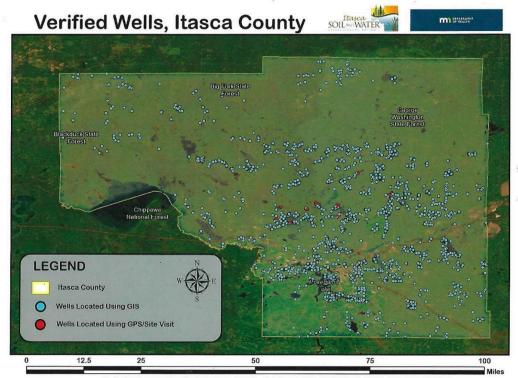
Year to date expenses: \$19,603 vs total budget \$37,745
